

# 2020 Indigenous Justice Legal Program Internship

# JOB POSTING AND POSITION OVERVIEW

The American Civil Liberties Union of Montana (ACLU of Montana) seeks applications from current law students for its summer Indigenous Justice Legal Internship Program. A successful candidate would work out of the Missoula office.

The organization's top priority areas are Indigenous Justice, criminal justice reform, and immigrants' rights. We work on a range of additional issues including reproductive justice, voting rights, freedom of speech and religion, LGBTQ rights, and informational and digital privacy. Interns will have the opportunity to work on a variety of litigation matters and work alongside the attorneys to address current civil rights issues in the state of Montana.

Over the past three years we have worked to build Indigenous Justice into every aspect of our organization through building relationships with Indigenous leaders and community members and prioritizing issues identified by Indigenous communities. To that end, the ACLU of Montana has a dedicated Indigenous Justice Legal Program—including a dedicated Indigenous Justice Legal Fellow—to work on a variety of issues that impact Indigenous people, including tribal sovereignty, voting rights, education equity and school discipline, discrimination, and the criminalization of poverty.

Indigenous Justice Legal Interns will have the opportunity to work alongside the attorneys on a variety of litigation matters directly addressing Indigenous rights issues in the state of Montana, with potential opportunities to also assist with our work on other civil liberties issues.

### BACKGROUND

The ACLU of Montana (founded in 1972) is an affiliate of the national ACLU (founded in 1920) and operates as a private, non-profit organization. We are the state's largest and most influential civil rights organization, combining litigation, policy advocacy, communications, and organizing tactics to promote a broad range of individual rights and liberties.

The ACLU of Montana has a current staff of 15 and a main office located in Missoula. Expect a fast-paced and friendly work environment, with flexibility and consideration of personal needs and circumstances. - A demonstrated commitment to public interest law and civil liberties, with a specific emphasis on Indigenous Justice.
- Current law student who will have completed their first year of school before the internship commences.
- Ability to commit to work in the office on a full-time basis for a 10-week period.
- Willing and able to work out of the Missoula office.

### COMPENSATION

The ACLU of Montana will provide support for outside funding applications, or efforts to receive course credit or work/study funding from the student's school.

### **APPLICATION PROCEDURE**

All applications are treated confidentially. Applications will be considered on a rolling basis, with initial review beginning on December 1, 2019. Interested students are encouraged to apply as early as possible. Submit a cover letter (please indicate where you saw this internship posting); resume; a short writing sample (no more than 10 pages in length); and a list of three references.
